FAQs

Q: Why should we begin using NHI?

A: You will collect more out-of-state Medicaid accounts than you currently do, for less than it costs you now, without giving up control.

Q: How does NHI work?

A: We do everything your business office would do on out-of-state Medicaid accounts. Use us for all states or simply those you have difficulty with. You receive monthly reports showing all activity and payments are sent directly to us, payable to you.

Q: What if we’re already outsourcing to another billing service?

A: You may send us accounts not yet submitted to your existing service. We can process accounts up to one year from the date of service.

Q: Does NHI require a contract?

A: No.

Q: Does NHI require a set-up fee?

A: No.

Q: Are there filing limits?

A: Yes. One year is the most common, although limits for designated HMOs vary. Accounts already written off may be collectible.

A: Simply send us an account.

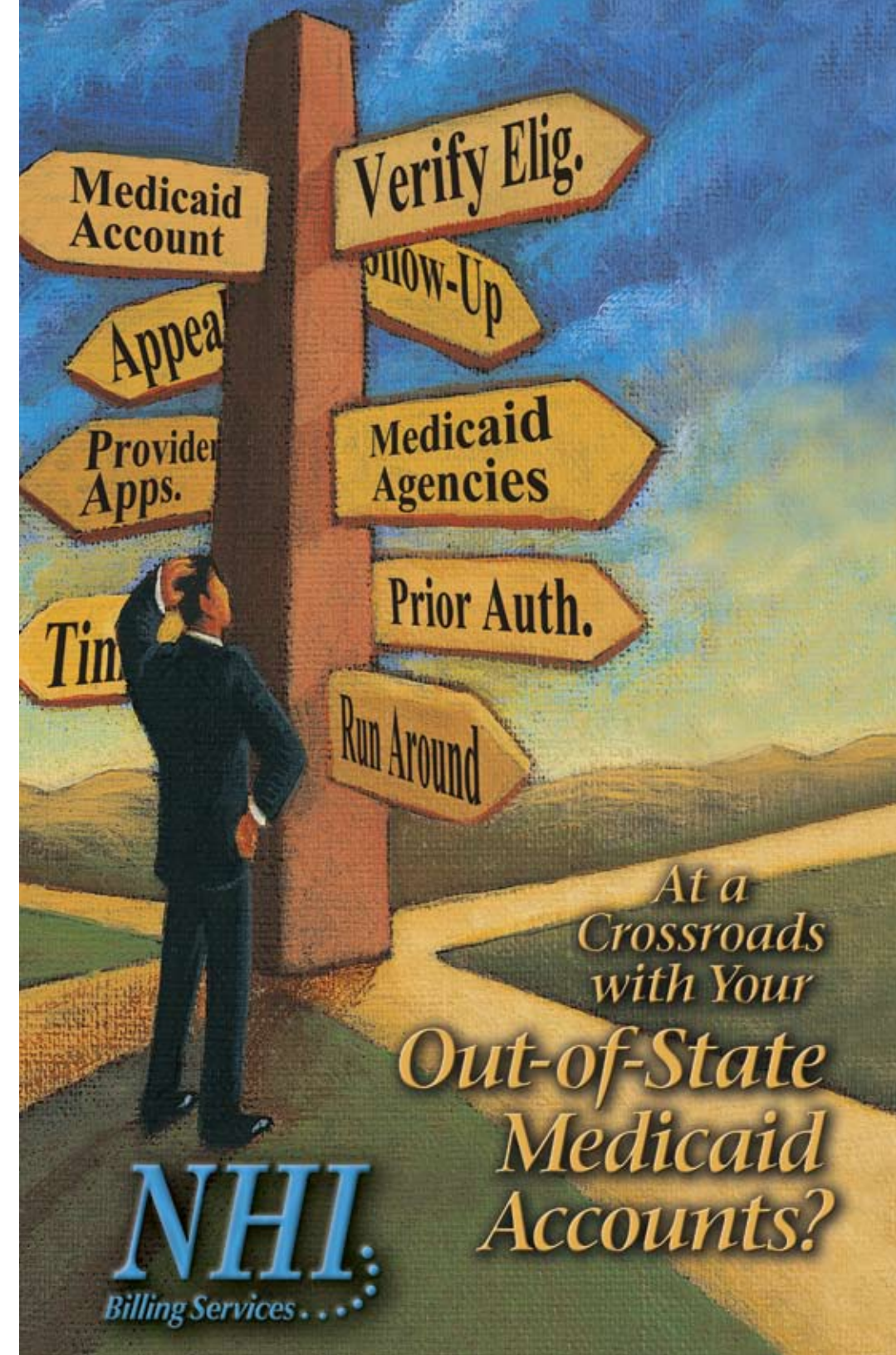

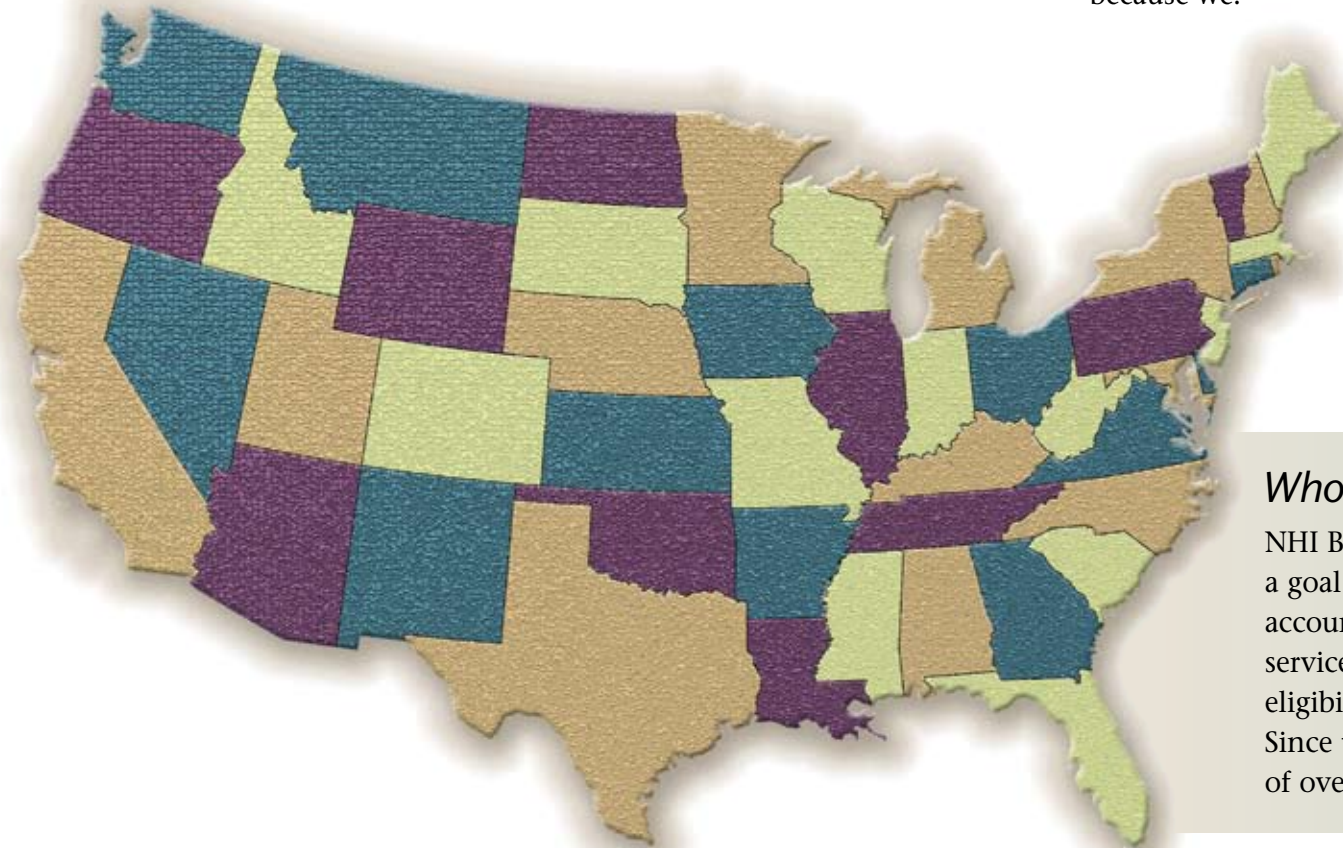
